- The food and beverage sales Vendor Menu is subject to approval by the event Coordinator. No Vendor will be permitted to sell alcohol.
- Non-profit 501(c)3 Organization—A \$25.00 deposit is Refundable on the day of the event. The space is 10' x 10' and has no electricity for non-food and beverage sales. An IRS Certificate is required with the application.
- Set Up/Tear Down: Vendors may arrive as early as 7:30 a.m. and no later than 8:30 a.m. ALL set-up vehicles must be off the property by 8:30 a.m.
- Vendors may begin to tear down no earlier than 3:00 pm and must be out by 5:00 pm.
- A vendor must have a canopy/tent and is responsible for its tents, chairs, tables, weights etc.
- Trash removal is the vendor's responsibility, and the space must be cleaned thoroughly prior to departure.
- This is a rain-or-shine event.
- A Certificate of Insurance is required to be submitted with this application.
